

Statement on principal adverse impacts of investment decisions on sustainability factors

Financial product: Tabula EUR IG Bond Paris-Aligned Climate UCITS ETF							
Summary: Tabula EUR IG Bond Paris-Aligned Climate UCITS ETF, a Sub-Fund of Tabula ICAV, considers principal adverse impacts of its investment decisions on sustainability factors. This statement on principal adverse impacts on sustainability factors covers the reference period from 1 January 2023 to 31 December 2023. Data is sourced from MSCI ESG Research except where otherwise stated. The assets under management used to calculate the metrics are shown in Appendix 1. The Sub-Fund is designed to track the performance of the Solactive ISS Paris Aligned Select Euro Corporate Bond Index. This is a reference benchmark meeting the criteria for an EU Paris-aligned Benchmark (PAB) described in regulation (EU) 2020/1818.
